Schedule of 2026-2027 Fees and Tuition

- Application Fee: **\$50 per student** (due with application, non-refundable)
- Enrollment Fee Per Family (due at time of enrollment, non-refundable)
 - **\$350** (1/27-2/28)
 - **\$450** (3/1-4/30)
 - **\$550** (5/1 and after)
- Technology Fee: **\$100 per student** in grades 1-8 (due at time of enrollment, non-refundable)

Returned Payment Fee: **\$30** (this remains with FACTS)

Tuition Late Fee: **\$30**

All payments are due on the first day of each month. Payments are considered late if they are not received by the tenth day of the month.

- After-School Care
 - 2:45p-3:15p **\$8** per student
 - After 3:15p, cost increases to **\$18 total** per student. ASC is offered until 5:30 each regular school day.
 - A late fee of **\$10** will be assessed per student after 5:35 pm. Beginning at 5:45, there is an additional **\$75** charge per student.
- Early Bird
 - 7:00a-7:30a **\$8** per student

Annual Tuition includes a 3% discount.

Monthly payments are drafted June-April.

Financial Aid is available and is handled solely through FACTS. We encourage families to apply through the FACTS Family Portal.

Enrollment may be cancelled in writing without penalty prior to June 1st. **This does not apply to the non-refundable application, enrollment, and technology fees.**

If families choose to withdraw from the program **June 1st and after**, there will be a **\$500 withdrawal fee** incurred, regardless of circumstances.

The costs associated with lunches, class trips, yearbooks, and our Early Bird and After School Care programs are not included in tuition and will be assessed separately. Every family is required to set up an account in their FACTS Family Portal for incidental charges.

Multi-child discount available: The third sibling and thereafter qualify for a **50% tuition discount**.

If a student is not accepted to THA, all charges will be refunded with the exception of the application fee.

Both annual and monthly tuition include the Dewar Tuition Repayment Plan. From the beginning, our goal is to be fully transparent and eliminate surprise or add-on fees. By streamlining tuition and including this plan upfront, families know exactly what to expect financially, and the school is able to plan responsibly and remain fiscally sound. This clarity allows us to keep tuition affordable, aligned with other area private schools, and focused on providing high-quality programs, staffing, and resources for our students.

Educational Scholarship Trust Fund Program:

We encourage our families to apply for the ESTF Program. This is exclusive to South Carolina families, and we have many students who are eligible to qualify for these funds. Funds are first come, first serve, so please do not delay in applying. For the 2026-2027 school year, the awarded amount will be \$7,634 per student. This is an excellent opportunity!!
